## Judging

Judging and scoring will be based on the following criteria: understanding of constitutional principles (35 points); clarity and effectiveness in expressing the theme (30 points); originality (15 points); grammar, spelling, and composition (15 points); and use of footnotes, endnotes, or bibliography (5 points). Not meeting the submission deadline, providing false entry information, and plagiarizing content are grounds for disgualification.



Awards will be announced in August and presented at a Constitution Day Event in September 2017. Winners will be asked to submit a picture and release form allowing the Fourth Circuit to publish their essays on court websites and at public events.
